

## **Expert group meeting on optimizing SDGs implementation in the framework of integration and policy coherence**

Friday and Saturday, 12-13 July 2019, New York

### **Introduction**

The implementation of the 17 Sustainable Development Goals (SDGs) by 2030 requires strategic policy prioritization, resource allocation and political investment by national governments, in close consultation with all relevant stakeholders. Making these decisions in turn requires careful analysis of the interlinkages, nexus areas, synergies and trade-offs among the SDGs, with the aim to identify areas of intervention that would maximize the SDGs achievement. The expert group meeting aims to bring government policymakers and representatives from the civil society and the UN system to identify tools, institutional mechanisms and strategies to effectively analyze and address these interlinkages and trade-offs with a view to developing most optimal policy interventions for the SDGs in the framework of integrated approaches and policy coherence. This year's meeting builds on the outcomes of the *expert group meeting on promoting integrated approaches to sustainable development* held in July 2018 in New York, which explored the concept of integrated approaches in-depth, uncovering their opportunities and challenges for sustainable development.

Multiple efforts are already underway in various sectors to better understand the interlinked nature of the 2030 Agenda and implement the SDGs in a synergistic manner. The recently held *Climate and SDGs Synergy Conference* (1-3 April 2019, Copenhagen), for example, focused on strengthening the linkages between climate action and the SDGs and realizing synergistic implementation on the basis of these linkages to maximize co-benefits. The Regional Forums on Sustainable Development also underscored “the need to accelerate efforts and adopt coherence and integrated policies that looked at the interlinkages between the Goals... together with good governance and appropriate and effective investments which were vital for the development and implementation of policies to lead countries to a truly sustainable future.”<sup>1</sup>

The present meeting on optimizing SDGs implementation seeks to expand and systematize these efforts to 1) better understand and properly analyse the interlinkages among the SDGs; 2) discuss emerging best practices and innovative approaches in cross-sectoral implementation of the SDGs, taking stock of existing measures applied for individual SDGs and, where relevant, identify how these can be combined to achieve maximum impact; and 3) share views on effectively communicating the policy implications of trade-offs where they exist.

These discussions will be anchored in the framework of “integrated approaches” and “policy coherence” for sustainable development, which are essential enablers for streamlining policies and effectively mobilizing the means of implementation to achieve results. Particular attention will be given to showcasing the draft methodology for SDG

indicator 17.14.1 “Number of countries with mechanisms in place to enhance policy coherence for sustainable development” (designed to measure SDG target 17.14 “Enhance policy coherence for sustainable development”).

### **Modality**

Co-organized by the UN Office for Sustainable Development of the Department of Economic and Social Affairs, the UN Environment Programme and the Organisation for Economic Co-operation and Development (OECD) Directorate for Public Governance, the meeting will consist of five moderated sessions, with a view to facilitating interactive dialogues among some 50 participants. Most participants will be drawn, on a first-come, first-served basis, from national delegations to the High-level Political Forum on Sustainable Development. Other participants will represent the UN system, international organizations, and major groups and stakeholders. The meeting will be conducted in English only.

### **Outcomes**

Participants develop a practical understanding of the system of interlinkages and interactions among and within the SDGs within the framework of integrated approaches to and policy coherence for sustainable development. This understanding is expected to enable participants to develop more effective and resource-efficient policy planning, implementation and monitoring processes for the SDGs. The meeting will result in a detailed report with concrete take-away messages for participants, and feed into the development of a toolkit for assessing the SDGs interlinkages, interactions and tradeoffs, with focus on the environmental dimension.
