Session One(Monday 11 April 2022) Opening and Quality Education



Mr. Alexander Trepelkov Officer-in-Charge Division for Sustainable Development Goals (DSDG), UN DESA

**Mr. Alexander Trepelkov** is Officer-in-Charge of the Division for Sustainable Development Goals (DSDG) in the UN Department of Economic and Social Affairs (UN DESA). The Division serves as the global secretariat for the 17 Sustainable Development Goals of the 2030 Agenda for Sustainable Developments, with a focus on providing substantive support, integrated policy analysis, building multistakeholder partnerships and capacity development in thematic areas such as water, energy, climate, ocean, transport, science and technology, as well as special concerns of small island developing States (SIDS).

In 2010-2018, he was Director of the Financing for Development Office, where he worked since 2000. His previous work in UN DESA was in the areas of Macro- and Micro-economic and Social Policy Analysis and Public Administration and Finance. Prior to joining the UN Secretariat in 1989, Mr. Trepelkov was employed for 12 years in the Russian diplomatic service.





Mr. Chun Kyoo Park Head United Nations Office for Sustainable Development

**Mr. Chun Kyoo Park** is the Head of the UN Office for Sustainable Development as of 26 October 2020. Before that, he has served at the government for almost 30 years mainly at the Ministry of Environment of the Republic of Korea where he joined in 1991 starting at mid-level management rising to the rank of the Vice Minister of Environment. Throughout the experience, he has built various capacities and broadened the scope of work by engaging in many different areas of sustainable development.

Mr. Park's works range from air and water quality management to nature conservation, waste management, chemicals management, sewerage system, etc. Tackling climate change has been his major concern and produced lots of achievements at the ministry including setting up Korean National Mitigation Targets.

Moreover, his career stretches to international cooperation where he worked as the first secretary of the Republic of Korea Mission to the UN in charge of works related to the UN General Assembly 2nd Committee, and the Commission on Sustainable Development. He has attended various international meetings which include CBD COP13 in Cancun, Mexico as the chair of the COP12 Presidency and most recently the 4th UN Environment Assembly in 2019 in his capacity as the head of the Korean delegation. He worked closely with UN organizations to support programs such as the UNEP's PAGE (Partnership for Action on Green Economy) and the first international workshop for developing country officials on MRV (Measurement, Reporting, and Verification) jointly with UNFCCC and/or EU.

He graduated from Yonsei University majoring in Public Administration and holds a Master's degree in Development Policy and Public Administration at the University of Wisconsin at Madison. He is coauthor of three books including "Carbon Market, Are You Ready to Buy or Sell It."



**Dr. Jean D'Aragon** is the Senior Sustainable Development Expert at the United Nations Office for Sustainable Development (UNOSD), where he also served as the Officer-in-Charge between April 2019 and October 2020.

He has more than 25 years of international development experience in research, policy capacity building, and monitoring and evaluation related to sustainable development in America, Europe, Africa, Asia and Oceania. Mr. Jean D'Aragon worked at the UN-Habitat headquarters in Nairobi, Kenya and the UN DESA United Nations Centre for Regional Development (UNCRD) in Nagoya, Japan linking climate change, natural disaster risk and vulnerability reduction, urban planning and governance.

Mr. D'Aragon has also been called upon to undertake assignments as Early Recovery Advisor and Early Recovery National Coordinator with UNCRD, UN-Habitat and other UN agencies such as UNDP, in various geographical contexts, including disaster-hit regions of the Philippines and Vanuatu or in Cameroon, where he developed and coordinated programs combining food security and poverty reduction with women and youth job creation and empowerment, particularly in the Far North Region of Cameroon, which is severely affected by Boko Haram's insurgency, adding to existing land use agro-pastoral conflicts and tensions exacerbated by increases in drought and flooding associated with the adverse effects of climate change.

Prior to joining the United Nations, Mr. D'Aragon worked as the Senior Programme Officer at the International Development Research Centre (IDRC), leading research on the interlinkages between urban poverty reduction, livelihood and food security, access to housing, water and sanitation, solid waste management, environmental protection and resilience building, supporting their integration into territorial planning policies, codes, regulations, plans mainly in developing countries, work he had initiated in the mid-1990s in the context of immediate postapartheid South Africa. Mr.D'Aragon also taught and lectured in different universities in Brazil, Portugal, France and in Canada, particularly at the Faculty of Engineering of McGill University, where he earned his Ph.D.



Ms. Lichia Saner-Yiu UNOSD Consultant

**Lichia Saner Yiu**, born in Taipei in 1949 and a Swiss citizen, holds a doctorate in Educational Psychology from Indiana University. A former associate professor at Chinese Culture University, Chinese Taipei, she was a post-doctoral fellow at Columbia University in organisational psychology. She is fluent in English and Mandarin.

Dr. Yiu has over 20 years of experience as an advisor to governments and international organisations on organisational development and reform of public administration. She recently directed a two-year, bilateral Swiss-Slovene project to reform the public administration of Slovenia and a three-year Sino-Swiss bilateral programme to modernise management training of senior civil service officials in China. She has also been a consultant to the United Nations Development Programme and other specialised UN agencies, as well as to private-sector organisations.




Andreas Schleicher is Director for Education and Skills, and Special Advisor on Education Policy to the Secretary-General at the Organisation for Economic Co-operation and Development (OECD) in Paris.

He initiated and oversees the Programme for International Student Assessment (PISA) and other international instruments that have created a global platform for policy-makers, researchers and educators across nations and cultures to innovate and transform educational policies and practices.

He has worked for over 20 years with ministers and education leaders around the world to improve quality and equity in education. Former U.S. Secretary of Education Arne Duncan said that Schleicher "understands the global issues and challenges as well as or better than anyone I've met, and he tells me the truth" (The Atlantic, July 11). Former UK Secretary of State Michael Gove called Schleicher "the most important man in English education" – even though he is German and lives in France.

Before joining the OECD, he was Director for Analysis at the International Association for Educational Achievement (IEA). He studied Physics in Germany and received a degree in Mathematics and Statistics in Australia. He is the recipient of numerous honours and awards, including the "Theodor Heuss" prize, awarded in the name of the first president of the Federal Republic of Germany for "exemplary democratic engagement". He holds an honorary Professorship at the University of Heidelberg.



Mr. Manos Antoninis, Director of Team, Global Education Monitoring Report Team, UNESCO **Manos Antoninis** is the Director of the Global Education Monitoring (GEM) Report since 2017. He was previously responsible for the monitoring section of the report. He coordinated the financing gap estimates for the 2030 education targets, the projections on the achievement of universal primary and secondary education completion, and the World Inequality Database on Education. He has been representing the report team in the Technical Cooperation Group on SDG 4 indicators, which he is currently co-chairing.

Prior to joining the team he worked for 10 years on public finance, monitoring and evaluation projects in education including: a public expenditure tracking and service delivery survey of secondary education provision in Bangladesh; the evaluation of a basic education project in the western provinces of China; the mid-term evaluation of the Education For All Fast Track Initiative; the annual reporting of progress in the implementation of the Second Primary Education Development Project in Bangladesh; a basic education capacity building programme in six states in Nigeria; the evaluation of an inservice, cluster-based teacher training programme in Pakistan; and the country study of the Out of School Children Global Initiative in Indonesia. He holds a DPhil in Economics for a study of technical education and the labour market in Egypt, completed at the Centre for the Study of African Economies of the University of Oxford.

Raymond Saner is Titular Professor at Basel University (Economics Department) and has been teaching at Sciences Po, Paris (Public Policy) and at Lüneburg University (Environmental Negotiations). His research projects focus on sustainable development, international relations, trade and public administration. He is co-founder of CSEND, Geneva based NGRDO (nongovernmental research and а development organization, 1993-present) accredited by ECOSOC with consultative status and expert working for international organizations, national governments and CSO organisations. Raymond Saner is a reviewer of management journals and author of books and journal articles and serves as officer in professional organizations such as the Academy of Management (Board member of ODC division (2002-2004), Chair of Advisory Council of AoM to Board of Governors (2000-2002), is representative to the UN in Geneva for the International Association of Applied Psychology and has been a long time member of the International Institute of Administrative Sciences (IIAS). He participates in the United National Task Force on Solidarity and Social Economy (UNTFSSE), is member of the bureau of UNECE's PPP unit, works for UNDESA on projects relating to the 2030 Agenda and the 17 SDGs (http://www.csend.org/publications/agenda-2030) and is a scholar in the field of international negotiations and conflict resolutions.

**Erik Swars** is Head of International Affairs at the Swiss Federal University for Vocational Education and Training (SFUVET) since 2013, Switzerland's expert organisation for VET. H.E. Ms. Youngsook Cho Ambassador for Gender Equality, Ministry of Foreign Affairs, Republic of Korea; Chair of International Solidarity Centre, Korean Women's Association **Ms. Youngsook CHO** is a feminist movement activist with long experience. She was a founding member of the Incheon Women's Workers' Association in 1988. And she has been working for the Korea Women's Associations United (KWAU) since 1996. She has participated in activities to realize women's rights and gender equality in the process of democratization and peace building process on the Korean peninsula. And in the early 2000s, she took the lead in protecting victims of GBV and changing the discriminatory legal systems and gender norms.

Since the late 2000s, she has sought to accelerate the implementation of global agreements on gender equality and women's empowerment, including CEDAW, BPfA, UNSCR 1325 and SDGs. Since Korea became an OECD/DAC member in 2010, she conducted many research, analysis and training related to gender and development.

She currently represents women's voices in a number of institutionalized governance systems, including UNSCR 1325 NAP Joint Committee under the MoGE, Action with Women and Peace under the MoFA, Gender Experts Committee of the KOICA and International Human Rights Experts Committee of the NHRI.

She received a master's degree in women's studies and studied international relations and political economy.



**Dr. Amanda. Kaisu currently leads talent scouting at Travelling University, also part of the Mondragon Team Academy, a cooperative specialized in international learning experiences that embrace diversity, team learning and entrepreneurship skills development. Her experience includes training and empowering teams of youth and adults towards collaborative learning and team entrepreneurship in an international context.



Dr Soma KP is a founder member and a national facilitation team member of MAKAAM - the Women Farmers Rights Forum(makaam.in) - spread over 24 states of India; she leads the work on Forest Rights and commons governance and on Farmers collectives. She is a member of the Community Forest Rights learning alliance (CFR la) Steering committee; a founder core group member of the Vikalp Sangam (forum for a confluence of alternatives https://vikalpsangam.org/about/ ), as well as a Steering group member of Forum for Policy Dialogue on Water Conflict in India. Her papers in several publications cover a gender perspective on a wide range of subjects from Commons, Women's Inheritance Rights, micro finance and on forest and natural resource policy regimes from a gender lens as well as examining the patriarchies in forest regimes. She straddles the space between policy analysis from a gender and equity lens and building grassroots leadership and institutions to bring those voices to policy discourse. Soma's efforts through action research with people's organizations on land, forest commons and water issues as well as issues of micro finance and empowerment. Her PHD research from IIT Bombay focused on Gender and ecology and the interface with developmental policy.



Dr. Soma Kishore Parthasarathy Policy analyst/specialist gender and development/ evaluator/advisor; Women Farmers Rights Forum - forest agroecology common rights (MAKAAM), India Dr Soma Kishore Parthasarathy, received her Masters Degree in Geography from JNU, MPphil in Urban and Regional Planning from CEPT University Ahmedabad and PhD from IIT Bombay. Her expertise lies in gender and development, livelihoods, poverty alleviation and environmental justice issues. With more than 3 and half decades of experience with the government of India (GOI- Deptt of Women and child development- as the initiator of gender training for policy makers, and the first gender analyst on policies within the state, she contributed to formulation of gender inclusive policies and programme development in the 80s and early 90s through the formulation of the National Perspective Plan for Women and the formulation of policies for the National Credit Fund for Women and the National Commission for Women.

She served with UNDP India as senior Advisor, Gender and Livelihoods to advice on the design and strategy of the predecessors of the NRLM – the Jharkhand and the Rajasthan Livelihoods Missions (2010 -2013); and on National Advisory Committee member for Mahila Samakhya (GOI) and to several states across India- Uttarakhand, Assam, Jharkhand and Andhra Pradesh. She served as Sector consultant with the Planning Commission, GOI for 10th and 11th Five Year Plans; as gender and NRM resource person to OXFAM/NOVIB; and as Gender Advisor to CIDA (1998-2002)

Research Training and advisory roles : She has undertaken several research assignments for training needs assessments with CIRDAP, with UNICEF; evaluation studies with UNDP, with Centre for World Solidarity on Gender and Watershed Development and with ICRW on intimate partner violence and institutional response processes of Kudumbashree program; with ASTHAA and Jan Chetna Sansthan on Livelihoods, land rights and empowerment of Adivasi women; and on education empowerment and the micro credit and SHG sector with NIRANTAR. As a resource person and researcher with AWID she sought to build the Commons perspective as well as to build a gender perspective on micro credit. Her efforts have been to bring an integrated feminist view of gender equality and environmental concerns in Commons and ecological discourses from a grounded gender perspective.

# Session Three(Wednesday 13 April 2022) Life Below Water



Mr. Andrew Birchenough Office for the London Convention/Protocol and Ocean Affairs, Marine Environment Division, International Maritime Organization (IMO), London, United Kingdom

Andrew is the Technical Officer for the Office for the London Convention/Protocol and Ocean Affairs at the International Maritime Organization (IMO). He has a background in applied environmental research, focusing on marine pollution and ocean and coastal zone management, and holds a doctorate from Newcastle University. He joined the IMO in 2017, his primary task being to support the implementation of the London Convention and Protocol, the international treaties that regulate the dumping of wastes and other matters at sea. He is also involved in the Office's Ocean Affairs portfolio, including the Joint Group of Experts on the Scientific Aspects of Marine Environmental Protection (GESAMP) and in other IMO Marine Environment Division work including on Particular Sensitive Sea Areas (PSSAs), matters related to the 2030 Agenda for Sustainable Development and the SDGs, and leading on anthropogenic underwater noise. Prior to joining IMO, he worked for Cefas and was responsible for providing scientific policy and regulatory advice to UK Government and regulators on the potential risks and impacts to the marine environment, and represented the UK at international and regional fora.



Ms. Fabienne McLellan Managing Director, OceanCare, Zurich, Switzerland

Before joining OceanCare in 2014, an international marine conservation organisation holding UN ECOSOC Special Consultative Status, Fabienne McLellan gained many years of professional experience in the financial sector and completed a Bachelor's Degree in Communication and Business at the University of Applied Sciences for Business Administration in Zurich and a Master's Degree in Environment Conservation and Sustainability at Monash University in Australia. During such Masters Degree, Fabienne McLellan became familiar with the Millennium Development Goals and subsequently, the Sustainable Development Goals and since has become a passionate advocate of the Agenda 2030 for Sustainable Development.

In her role as Managing Director of OceanCare, she is leading the organisation's work in international fora together with her colleague, Nicolas Entrup. Fabienne McLellan has attended many UN meetings under the UN Convention of the Law of the Sea in New York (UNCLOS) (ICP17-21, BBNJ IGC3, IGC4), the UN Environment Programme in Nairobi (UNEP) (UNEA4, UNEA5) and UN daughter agreements (CMS COP12, COP13), the UN Ocean Conference in 2017, as well as conferences of different Multilateral Environmental Agreements (MEAs) (IWC, RFMOs etc.). OceanCare is embedding the SDGs in all of their projects and the Agenda 2030 is our guiding framework. For the UN Ocean Conference in 2017, we have submitted 5 voluntary commitments and are just in the process of developing new voluntary commitments for the UN Ocean Conference this year.





Mr. David C. Smith Professor, Director, Centre for Environmental Management, Coordinator, Institute for Sustainable Development, The University of the West Indies, Jamaica

**David** coordinates the Institute for Sustainable Development at The University of the West Indies. He was an author of the United Nations Global Sustainable Development Report 2019 and a member of the Science and Policy Advisory Committee of the Interamerican Institute for Global Change Research and is the Caribbean Chair of the Sustainable Development Solutions Network.

He focuses on environmental management, managing disaster risk and the effects of climate change on human wellbeing, mainly in Small Island Developing States.

David's Ph.D. in Zoology is from the University of the West Indies and he lectured there prior to managing the Jamaica Conservation and Development Trust an NGO that worked on environmental conservation. While there, he helped to establish the Jamaican system of National Parks and Protected Areas, established an environmental funding mechanism, served on the board of the Caribbean Conservation Association and was a Regional Councillor for IUCN, the World Conservation Union. Following this he worked at UNDP as Assistant Resident Representative in the Jamaica Office in charge of UNDP's Environment, Energy, Climate Change and Disaster Management and response activities in the Bahamas, Bermuda, The Turks and Caicos Islands, The Cayman Islands and Jamaica.



Mr. Peter McIntyre Associate Professor of Natural Resources & the Environment, Dwight Webster Sesquicentennial Faculty Fellow co-Director of the Adirondack Fishery Research Program, Cornell University **Peter Mcintyre** is an aquatic conservation ecologist and the Dwight Webster Sesquicentennial Faculty Fellow. Working with a wide range of collaborators, he develop management approaches that balance human interests with protecting biodiversity. Their work is worldwide in scope, using detailed field studies at sites in New York, the Great Lakes, East Africa, Southeast Asia, and Hawaii to gain general insights and identify global patterns.

Mr. Feras Ziadat Land Resource Officer, FAO. The State Of The World's Land And Water Resources For Food And Agriculture Systems at breaking point

**Feras Ziadat** is Land and Water Officer (UNFAO), focusing on land resources planning tools and approaches to support integrated land and water management, participatory land use planning, combating land degradation and desertification, integrated landscape management and sustainable land management. Formerly a senior scientist on soil conservation and land management at the International Center for Agricultural Research in the Dry Areas (ICARDA) and an associate professor at the University of Jordan. Currently coordinating the FAO flagship report "The State of the World's Land and Water Resources for Food and Agriculture – SOLAW", and the Chair of the UN Coalition on Combating Sand and Dust Storms.



Ms. Neelkamal Darbari IAS/Small Farmers Agribusiness Consortium

**Neelkamal Darbari**, IAS, is a Secretary level Officer in Government of India, posted as Managing Director, SFAC (Small Farmers' Agribusiness Consortium) in New Delhi. She is currently leading efforts towards expansion of eNAM and aggregation & economic inclusion of small and marginal farmers in agribusiness activities through the new initiative of Gol for promotion of 10,000 FPOs. Earlier, as Additional Chief Secretary (ACS) Agriculture and Horticulture, Rajasthan, she had been responsible for formulating outcomes based policy frameworks and promoting sustainable agricultural practices. She led the Global Rajasthan Agritech Meet (GRAM) by conceptualising and driving the campaign in key districts of Rajasthan to provide the right investment thrust in agribusiness for augmenting farmers' incomes.

As Joint Secretary and Advisor, National Disaster Management Authority (NDMA), was in charge of the first-ever Direct Benefit Transfer initiative under Prime Minister's Relief Fund during Jammu & Kashmir floods of 2014. Gold Medalist in English, MBA from University of Southern Cross, Australi4 and an MPhil in Public Policy, she is an occasional writer for newspapers and is also a film critic with a very committed clientele.





**Mr. Jan-Gustav Strandenaes** Senior Adviser, Stakeholder Forum, London UK, and PURE Consulting, Oslo, Norway

Jan-Gustav began working with the UN on environment and governance in the 1970s, a first UN assignment brought him to Latin America. He then taught about the UN for more than five decades, worked with the UN Commission for Sustainable Development for 15 years, worked as NGO liaison officer at the UN HQ, worked as a diplomat for the Ministry of Foreign Affairs, Norway, at embassies in Botswana and Uganda, was for 15 years director of an aid/environment-NGO with projects in Africa, Asia, and Latin America, has worked 6 years in Africa, has extensive stakeholder experience through 50 years of work on all continents, speaks several languages, is a seasoned university lecturer, has guestlectured all over the world on UN issues; has evaluated projects and organisations in Africa, Asia, and Latin America, advised governments, chaired UN meetings, facilitated UN processes, translated and authored books and numerous articles on governance, the environment, and sustainable development.

**Claude R. Heimo** is an experienced Swiss senior natural resources management and environmental governance specialist dedicated to forestry, agriculture, biotrade, poverty-related issues, sustainable economic development and security in developing countries and emerging economies.



**Mr. Claude Heimo** Senior Adviser, Centre for Socio-Eco-Nomic Development (CSEND)

Between 1982 and 1998, he successively worked as Senior Forestry Officer of the FAO Investment Center in Rome and, later as Senior Forestry Specialist of the World Bank/GEF in Washington as task manager and team leader on forestry, agricultures, agroforestry, biodiversity, and environmental conservation issues in twenty-two countries of Asia, the Middle East and Africa (SSA).

After his early retirement from the World Bank in 1999, Claude R. Heimo collaborated with C-Send Geneva on various external assignments in China, Vietnam, Mongolia and Myanmar (marketbased instruments for environmental conservation – FAO/China); Earth Observation for the monitoring of Environmental Treaties (ESA-TESEO); in Vietnam in poverty reduction and BioTrade (SNV and UNCTAD/Swiss-Helvetas); and, since 2016, in China on food security and ecological protection and rehabilitation (under ADB assignments)

For his work on Ecological Security for Food Security in China (subject of this short presentation), Claude R. Heimo collaborated with Prof. Li Zhou (Chinese Academy of Social Science – CAAS and project director) and a group of Chinese provincial sector specialists. Their work, which started in 2016 in the Henan Province of China for the development of a provincial ecological security strategy, addressing food security issues, was in 2018 extended to the other major grain growing areas of China.





Mr. Jin Tanaka Branch Manager, UNISC International, a youth-led NGO with special consultative status to the UN ECOSOC As a member of YOUNGO, he participates in the activities of NDC and LCOY, and as Branch Manager of UNISC International, a youthled non-governmental organization with special consultative status to the United Nations Economic and Social Council, he is involved in advocacy for action on climate change and other environmental issues both domestically and internationally. He is also involved in advocacy activities in Japan and abroad. Especially in the field of climate change, he has been involved in advocacy activities from Local Conference of Youth (LCOY) to Conference of Youth (COY) in Glasgow, UK, Regional Conference of Youth (RCOY), virtual Conference of (vCOY), Mock COP 26, and as an observer at UNFCCC COP 26, he has been involved in advocacy for climate change activities on a broad scale. It is the policy to present concrete and science-based proposals for youth-led climate change measures by linking them to ocean conservation and energy measures, and he is conducting youth campaigns for climate change measures and climate adaptation in Japan and abroad, mainly in the Asia-Pacific region. In addition, the organization is also engaged in youth campaigns for climate change countermeasures and climate adaptation in Japan and abroad, mainly in the Asia-Pacific region.
