




USING SDG 6 POLICY SUPPORT SYSTEM (SDG-PSS) IN “CÔTE D’IVOIRE”



Overall status of SDG 6 at the national level

In Côte d'Ivoire, surface waters are plentiful. There are **4 national watersheds** (Agnéby, Bandama, Mé, San Pedro) and **7 transboundary river basins** (Bia, Cavally, Comoé, Niger, Nuon, Sassandra, Volta Noire). There is about **235 watercourses** (MINEF, 2022).

- ✓ **Indicator 6.1.1** Proportion of population using safely managed drinking water services
- ✓ **Indicator 6.2.1** Proportion of population using safely managed sanitation services, including a hand-washing facility with soap and water
- ✓ **Indicator 6.a.1** Amount of official development assistance spent on water and sanitation in a government-coordinated spending plan



Overall status of SDG 6 at the national level

The main Challenges :

- Operationalization of an Integrated Water Resources Management framework;
- Strengthening access to drinking water sources in rural areas : **71% in 2022**;
- Implementation of an improved sanitation system in rural areas;
- Implementation of urban sanitation master plans should increase wastewater disposal network and the treatment of wastewater.

We think about 90% of the people living in Côte d'Ivoire will benefit if we achieve SDG6.


