Mainstreaming the 2030 Agenda and the SDGs in Asia and the Pacific



- Mainstreamed and embedded SDGs into national development plans and strategies at medium- and long-term time horizons
 - Multifaceted approaches spanning policy integration, institutional frameworks, data enhancement, and targeted interventions



- Institutional mechanisms and governance structures for accountability and holistic development planning
 - For example: Sustainable Development Council in Sri Lanka, SDG
 Taskforce in Samoa, Inter-Ministerial Committee on SDG Monitoring in Bangladesh, National Committee for Sustainable Development in Thailand



- Whole-of-society and whole-of-government approaches
- Thematic and SDG budget tagging



- Expanding data availability on SDG indicators
 - Selection and prioritization of national indicators
 - Use of SDG data for evidence-based decision making

ESCAP provides analytical support to VNR-presenting countries.


ESCAP can aid in the analysis of SDG data, identify groups vulnerable to being left behind, assess levels of inequality, determine SDG impact, and estimate socio-economic and environmental effects of national policies.

This support can inform VNR analysis and ensure evidence-based policy formulation.



SDG Policy Analysis SDG progress assessment






 ESCAP's methodology measures current and expected SDG progress, enriching the VNR process with evidence.

The <u>National SDG Tracker</u>, currently used by 17 countries, analyses whether a country is on track to meet the SDGs and the chance of achieving its Targets by 2030, based entirely on national choice of target values, indicators and data.

The results guide the VNR consultations and enhance the VNR report with internationally-accepted analysis.

SDG Progress in Asia-Pacific 2023




Measuring inequality of opportunity and

identifying those left behind


Using Demographic and Health Surveys (DHS) and Multiple Indicator Cluster Surveys (MICS), ESCAP's Leaving No One Behind (LNOB) Platform helps identify and visually present the furthest behind in access to key services and opportunities at national and sub-national levels covering 16 SDG indicators in 30 countries across Asia and the Pacific.




Social Protection Simulator (SPOT)



Social Protection Simulation – Universal Child, Disability and Old-Age benefits in Maldives

Using latest data from household income and expenditure surveys, the **ESCAP Social Protection** Simulator estimates the impact of introducing social protection scheme poverty, inequality consumption. and computes the cost of simulated programmes, different providing illustrative options expand fiscal space for social protection. The Tool helps users with the designing of social protection schemes and can be used as direct inputs into the VNR analysis.



SDG 7 Roadmap for Fiji, 2021

National Expert SDG Tool for Energy Planning (NEXSTEP)

Methodology to assist energy Ministries to develop SDG 7 national roadmaps aligning national energy plans with SDG 7 and NDCs and to develop national energy transition pathways. The methodology includes three steps:

- energy modelling with estimated share of energy resources
- economic analysis to identify feasible options and
- scenario analysis of national policies and implementation


ESCAP has developed several **resources** and **e-learning tutorials on VNRs**

VNR policy briefs provide policy makers with practical tools and ideas to address common challenges in the VNR process.


Stakeholder engagement Putting the VNR into action
